Public Notice

Property Tax Notices Mailed

The 2023 Annual Property Tax Notices were mailed on May 15. Watch your mailbox and notify the tax department if your mailing address has changed.

Property taxes are due on June 30 for the current taxation year (January 1 – December 31, 2023). A penalty of 5% will be applied on July 5 to taxes not paid by the due date.

Property owners are responsible for full payment of taxes and penalty for late payments. Non-receipt of your property tax bill does not exempt you from penalty due to late payment.

If you have not received your notice by June 5, please contact the tax department.

SAVE TIME, PAY ONLINE! In your online banking, search "Canmore" to add the Town of Canmore Property Taxes as a payee. Enter your 5-digit Tax Roll number as the account number.

SET UP YOUR PAYMENT PLAN: Visit canmore.ca/tipp to enroll in our no-fee Tax Installment Payment Plan (TIPP) to pay your annual levy in convenient monthly installments.
